Typewritten applications and statements are preferred. **DO NOT SUBMIT A PERSONAL PHOTOGRAPH.** The selection process for this scholarship is conducted without regard to race, religion, sex or national origin.



1. Scholarship application. (first page)
2. Statement from applicant. (500 words or less autobiography)
3. Transcript of high school or college grades. High school transcripts must indicate class rank/class size and test scores.
4. List of extra-curricular activities, honors received, scholastic achievements or other significant accomplishments or activities including community contributions and jobs held. Use one side of 8 1/2" x 11" paper. Maximum two (2) pages.
5. Dated, signed letters of recommendation from at least two, but not more than four persons in authority. May be from school personnel, community leaders, etc.  
Letters may cover applicant's abilities, work habits, integrity, need and potential.
6. Photocopy of applicant's birth certificate or naturalization papers.
7. Application package should be stapled in the top, left-hand corner. Number of pages in package must not exceed 15. Do not put package in any type of folder.
